TERMS & CONDITIONS

- Booth size 8' x10' (actual dimensions may vary).
- Only 3 racks will be allowed in clothing booths. Extra charge will apply for each additional rack. Extra charges will also apply if the booth offers products from more than one category, eg. clothing and jewelry.
- 1 table and 2 chairs will be provided in each booth. Extra charges will apply for additional tables, chairs or electrical connections. Vendor must advise organizer at the time of booking, of any such requirements.
- No booth will be reserved until payment in full is received along with this contract.
- Vendors will be held responsible for any property damage, lost or stolen goods.
- There must be no food (consumable items) at the booth at any time unless specifically permitted by the organizers.
- Vendors must keep their booth clean and organized at all time.
- Booth must be set and ready to operate by 10:30 am.
- All vendors are required to be at the event and ready to operate by 11:00 am - any one arriving after the opening of the show at 11:00, will not be allowed to set up and no refunds will be given.
- No signs/posters are allowed to be posted on the walls. Signs must not block another vendor/pathway.
- All vendors are required to stay in their booths and are not allowed to disturb other vendors.
- All payments are final and no refunds or transfers will be allowed once the payment is made.
- Vendor hereby certifies that it holds all the licenses/permits required to operate its business at the event and that the business holds a valid Seller's Permit issued by the California Board of Equalization.

The vendor, its affiliated companies, and subsidiaries agree to be responsible for all damages, and to defend, hold harmless, and indemnify the organizer and its members and affiliates against all damages, including reasonable attorney fees, of liability whether by injury (including death) to the person or property of another or otherwise arising in connection with this agreement/event. All claims and disputes arising under or relating to this agreement are to be settled by arbitration in California. An award of arbitration may be confirmed in a court of competent jurisdiction.
